**Qualifications:** Each nominee will be reviewed by the selection committee based upon the qualifications listed below. Please limit each response to 100 words or less.

- Current involvement through philanthropy, volunteer service or continuing or second career.
- Impact of involvement by the nominee, what community need has been addressed?
- Why is the nominee deserving of the Ageless Remarkable Saint Louisan award?
