Who We Serve


The seniors served by St. Andrew's Charitable Foundation represent a vulnerable population, with unique and pressing needs. These seniors, aged 60 and older, are living on a meager average income of just \$15,000 per year. Their financial circumstances make it extremely difficult to afford essential necessities, including food, medications, housing cost and repairs, and healthcare. Additionally, many of these seniors may lack family resources or support, and they often live alone. St. Andrew's Charitable Foundation's mission is to provide critical assistance and support to these seniors, ensuring they can continue to live in the place they call home with dignity, safety, and comfort. The foundation's programs and services play a pivotal role in addressing the multifaceted challenges faced by this underserved population and contribute to enhancing their quality of life.

Direct Services to Seniors


From June 1, 2022, to May 31, 2023, St. Andrew's Senior Solutions charitable programs for low-income seniors, which is funded by St. Andrew's Charitable Foundation, served a total of 262 unduplicated seniors. These services play a crucial role in providing seniors with the opportunity to continue living safely, independently, and in good health within their own homes. Importantly, this support is made possible through the generosity of donors, as the services are provided at no cost to the recipients.

Dear Friends.

I hope you are well and enjoying the holiday season with friends and family. At this time of year, I feel blessed and thankful for my friends, family, and my health. The holidays are also a reminder that many in our senior community have no family or friends nearby to lean on; and many are not in good health. The seniors we serve are impacted by the rising costs in all aspects of their life while living on a fixed income. Seniors are choosing between paying for heat or medicine, groceries or rent, transportation or toiletries.

Together, we help meet the needs of older adults in our community who live on an average of \$15,000 a year or less. Our programs, Safe Home, Healthy Foods and Circle of Care, are a lifeline to numerous seniors throughout the St. Louis Metropolitan area. Many of the seniors we serve cannot afford groceries, live in food deserts with no grocery stores nearby and have limited or no transportation options. Many seniors are isolated with no family nearby, some don't know their neighbors. Our Circle of Care and Safe Home programs provide seniors the opportunity to remain living safely, independently, and healthy in their homes.

In the fall of 2022, we were thrilled to bring back our 18th Annual Ageless Remarkable St. Louisans Gala after a two-year hiatus due to the Covid-19 Pandemic. On Saturday, October 1, 2022, 300 guests gathered at the Hyatt Downtown to celebrate the Class of 2022 honorees, age 70 or better, that are making a positive impact throughout St. Louis. It was wonderful to be back in person to celebrate their accomplishments and raise vital funds for the seniors we serve.

St. Andrew's Charitable Foundation is dedicated to caring for our local seniors and because of you and your generous support, we can provide a healthier life for struggling seniors. It is only through your thoughtful and kind support that we can help meet the needs of an often-forgotten segment of our society, our senior citizens. OUR SERVICES

St. Andrew's Charitable Foundation plays a critical role in funding charitable in-home services for low-income seniors, enabling them to continue living safely and healthily in their own homes. This commitment to supporting aging in place has far-reaching benefits, not only for the seniors themselves but for society. Aging in place offers several advantages, including improved health and emotional well-being for seniors. They can remain in familiar surroundings, maintaining connections with their communities and enjoying a sense of independence and comfort. These factors are pivotal in enhancing their overall quality of life. Moreover, there is evidence to suggest that programs that facilitate aging in place can yield substantial cost savings. These cost savings extend to families, as they are not burdened with the high expenses associated with alternative senior care options, such as nursing homes. Additionally, governments and healthcare systems can benefit from reduced healthcare costs and lower rates of hospitalization. Our charitable programs include:

HEALTHY FOODS PROGRAM

The Healthy Foods Program is a pioneering initiative aimed at combating food insecurity among seniors.

As the first program of its kind in the St. Louis area, it focuses on delivering comprehensive support to seniors. This includes personalized home delivery of nutritious groceries, connecting eligible seniors with benefit counselors to apply for programs like the State Nutritional Assistance Program (SNAP), and providing valuable nutritional education. By offering not only food but also knowledge and resources, the program helps seniors access the sustenance they need while promoting better eating habits, all with the goal of enhancing their overall well-being and quality of life.





CIRCLE OF CARE

The Circle of Care program is a lifeline for seniors, offering crucial services that enable them to live independently and safely in the comfort of their homes for as long as possible.

Often, these services serve as an interim solution until seniors can access benefits like Medicaid or Veterans programs. This approach ensures that seniors can maintain their independence, stay out of the hospital, and delay entry into nursing homes until they are genuinely ready.

The program begins by assessing the specific needs of each senior, which forms the basis for establishing a personalized care plan. Services provided by direct care staff encompass a broad spectrum, including housekeeping, meal planning and preparation, personal care such as bathing and grooming, medication reminders and management, transportation, and more. Beyond these essential services, the program is dedicated to improving the overall quality of life for each senior and connecting them with vital community resources. Circle of Care is not just about immediate support; it's about fostering long-term well-being and independence.

At 92, Alma, battling heart disease and severe arthritis, relies on Circle of Care services to aid with daily tasks that became challenging for her. During a severe summer storm in St. Louis, Alma endured a lengthy power outage. Her St. Andrew's care manager promptly reached out to ensure her safety, verifying she could stay with nearby relatives. Upon her return, Alma faced a fridge filled with spoiled food. Struggling both financially and physically, Alma was unable to replace the spoiled food or clean up the mess. St. Andrew's Circle of Care stepped in, cleaning the fridge, while the Healthy Foods program delivered fresh groceries.

Alma, overwhelmed, expressed gratitude, sharing how blessed she felt to be a client of St. Andrew's. Alma's experience is a testament to our commitment to supporting seniors in times of need, even when storm cleanup and support aren't the primary focus of our programs. This flexibility and compassion are instrumental in ensuring that seniors like Alma can maintain their dignity and independence through adversity. Her story exemplifies the impactful support your contributions to St. Andrew's Charitable Foundation provides.

HOMER SCHMITZ MEMORIAL HEALTH CLINICS

The onsite health clinics, in partnership with Deaconess Faith Community Nurses, play a pivotal role in caring for high-need residents at three residential housing facilities for low-income seniors.

These clinics offer on-site, walk-in healthcare services at no cost, prioritizing preventative care and early intervention to prevent major health issues. By providing services that help manage chronic illnesses, both physical and mental, facilitating smooth transitions from acute or post-acute care, reducing avoidable hospital readmissions, addressing medication-related complications, increasing patient engagement, and minimizing the use of emergency medical transportation, these clinics not only enhance the well-being of residents but also contribute to the overall efficiency and sustainability of healthcare for this vulnerable population.

SAFE HOME FOR SENIORS

The Safe Home for Seniors program addresses a critical need among low-income seniors who wish to age in place safely.

Minor home repairs and modifications often stand as a significant barrier to this goal. Falls, a leading cause of injury and mortality among the elderly, can result in severe and permanent injuries, jeopardizing a senior's ability to remain in their home.

This program takes proactive measures to minimize the risk of falls and enhance home safety. It encompasses a range of essential repairs and safety modifications, such as fixing or replacing leaky and corroded faucets and pipes, door and window replacements, and repairs to decks, porches, steps, and floors. Furthermore, the program includes the installation of night lights, safety lights, locks, railings, grab bars, and smoke detectors, in addition to basic weatherization measures. Through these efforts, the Safe Home for Seniors program ensures that seniors can maintain their independence and well-being in a safe living environment, thereby reducing the risk of accidents and falls that might necessitate a move to more expensive care facilities.

Percy's story is a touching testament to the life-changing impact of the Safe Home for Seniors program. Percy, at 65 years of age, was living on a modest joint income of \$1,390 per month with his wife. His life took an unexpected and devastating turn when he developed a spine infection that required surgery. Regrettably, the surgery left him paralyzed from the waist down, dramatically altering his once active and independent lifestyle. Percy found himself homebound, unable to leave his home without immense effort and assistance from his family. The feeling of being a prisoner in his own home weighed heavily on him.



However, the Safe Home for Seniors program intervened and installed a chair lift at Percy's home, providing him with newfound mobility and independence. The transformation was nothing short of remarkable. The chair lift enables Percy to safely exit his home, restoring a vital sense of freedom and autonomy to his life.

Percy's reaction to the news that he would receive a chair lift speaks volumes about the positive impact of St. Andrew's Charitable Foundation. His overwhelming gratitude, happiness, and tears are a poignant reminder of the organization's mission to enhance the lives of seniors and provide them with the support they need to maintain their well-being and dignity.

Percy's life was significantly improved, thanks to the compassionate and life-changing support of St. Andrew's Charitable Foundation donors.






